



**LICENCE FOR SUBMISSION TO THE 'AISBERG' OPEN ACCESS INSTITUTIONAL ARCHIVE
OF THE UNIVERSITY OF BERGAMO**

NOTE

This licence is required of all those submitting documents to the open access institutional archive of the University of Bergamo. Submission of a document and corresponding biographical notes to the archive – by you personally or on your behalf by the library Services of the University of Bergamo – requires that you (author or owner of rights) fully accept the terms of the licence and grant the rights listed below.

Such rights are not exclusive: you may publish the document in current and future versions in any place and in any form. Submitting the document to the open access institutional archive of the University of Bergamo does not entail the suspension of intellectual property rights over the work.

NON-EXCLUSIVE DISTRIBUTION LICENCE

1. Granting of the licence

In signing and submitting this licence, I grant the University of Bergamo a worldwide licence that is free of charge, non-exclusive and of a duration equal to that of the authors' rights over the work, which authorises the University to exercise the rights listed below:
